<p>We declare,</p> <ul style="list-style-type: none"> ■ that consignments which we forward to airlines or regulated agents are/ have been protected against unauthorized interference during preparation, storage and where applicable also transport, inasfar as we are responsible for this. ■ that our staff charged with the preparation of the consignments are reliable and have been familiarized with their tasks and ■ that this procedure is documented with date and countersignature. ■ that consignments are prepared in secure premises. ■ that the consignments do not contain any prohibited objects pursuant to sections (iv) and (v) of the schedule (guidelines for classification of prohibited objects) according to paragraph 6.4.1. (c) of the annex of the VO (EG) No. 2320/ 2002, inasfar as they have not been registered according to ICAO/ IATA rules on hazardous goods. ■ that for security reasons packaging and contents of consignments may be examined (e.g. random checks). <p>We commit ourselves,</p> <ul style="list-style-type: none"> ■ to renew the security declaration in case our company name and/ or our address and any of our branches changes. ■ to ensure implementation of the security measures in case we employ subcontractors (transportation, packaging, storage). ■ to allow access to our premises to those in charge of validation e.g. aviation security authorities or the regulated authorized officers (this does not apply to state institutions which guarantee an adequate level of security protection). ■ that, without being requested to, we shall submit this original declaration every 12 months to the regulated authorized officer and/ or to the airlines. ■ that the packaging of air shipments will always be carried out in a manner to ensure their safety against manipulation. Specifically, safety against manipulation means that packages are prepared in such manner that interference with their contents without leaving visible traces is made impossible (e.g. wrapping in only sealed foil). <p>The only exemption therefrom concerns air shipments difficult to be wrapped in this manner or which can only be transported under separate control.</p> <p>In this case the matter is to be coordinated with the regulated authorized officer so that he may plan and calculate the details of the shipment. In the absence of a written agreement by the regulated authorized officer the obligation for wrapping in a manipulation- safe way remains in tact.</p> <p>to clearly mark air shipments as such, this in their EDP documentation as well as physically.</p>
